## **Membership Types**

### **1. Member Associations**

This class of membership includes Examining Bodies with members resident in NSWCHDI area of control that exist for the purpose of conducting amateur and professional highland dancing examinations in NSW and consists of a minimum of seven (7) financial members, resident in NSW.

### **2. Associated Association**

This class of membership includes an association in which all Office Bearers are elected from all members of the Association, the membership of the Association not being restricted to members of any particular studio and consists of a minimum of five (5) financial members resident in NSW.

### **3. Adjudicator Members**

Available to an individual who has passed the Judges Examination conducted by either the RSOBHD and/or ABHDI. Such member must be currently financial with ABHDI and/or RSOBHD and his/her name must appear upon the current RSOBHD and/or ABHDI Panel of Judges listing. Adjudicator Members are entitled to one (1) vote.

### **4. Teacher Members**

All Teachers residing in or, actively teaching in the State of New South Wales are entitled to have one (1) vote at general meetings - If more than one (1) teacher from the same studio is present, then that studio will only have one (1) vote.

### **5. Competition Organisations**

A Competition Organisation is one formed to conduct Highland Dancing competitions in NSW in accordance with RSOBHD and ABHDI rules and consists of a minimum of three (3) financial members.

Each Competition Organisation may be represented by one (1) delegate at general meetings - Competition Organisation Delegates are not entitled to a vote

### **6. Honorary Members**

Judges resident in NSWCHDI area of control who have been recognised as an Honorary Judge by either RSOBHD or ABHDI.

Any other individuals appointed by NSWCHDI at its discretion, who, because of their outstanding contribution to Highland Dancing in NSWCHDI area of control, warrant recognition. Honorary Members are **not entitled to a vote** and will pay no fees.
